Entered 21 century, a series of institutes for global history have established in China, including research center for global history of Capital Normal University, research center for cross regional civilizations of East China Normal University, institute for global and transnational history of Shandong University. Beijing Foreign Studies University also founded "institute for global history" in the end of 2014.
